A RESOLUTION AMENDING APPENDIX A, SCHEDULE OF FEES AND CHARGES, LAWTON CITY CODE, 2015, PERTAINING TO CHAPTER 19, RECREATION, BY AMENDING ARTICLE A-19-7 MISCELLANEOUS PROVISIONS AND PERTAINING TO CHAPTER 7, BUSINESS, BY AMENDING ARTICLE A-7-23 SOUND TRUCK/SOUND AMPLIFICATION EQUIPMENT PERMIT AND ARTICLE A-7-31 EVENT AND ASSEMBLY PERMITS TO ELIMINATE THE FEES ASSOCIATED WITH EVENTS FOR SPECIAL NEEDS INDIVIDUALS WHEN USING MIRACLE FIELD WITHIN ELMER THOMAS PARK.
