

**AMENDMENT TO AGREEMENT FOR PROFESSIONAL SERVICES
CITY OF LAWTON
LAWTON, OKLAHOMA**

CONTRACT AMENDMENT NO. 1

This Amendment to Agreement made as of this ___th day of January in the year two-thousand and twenty-five is by and between the City of Lawton, Oklahoma, a municipal corporation, hereinafter referred to as “First Party” or “Owner” and Jacobs Engineering Group Inc., hereinafter referred to as “Second Party” or “Engineer.”

WITNESSETH

WHEREAS the parties hereto have an agreement for professional services dated February 14, 2023, for providing project management services;

WHEREAS said Agreement provided in Exhibit B (Attachment A) the option for two one-year extensions;

WHEREAS the parties hereto desire to enter into an amendment to said Agreement to include additional professional services outlined herein, and all provisions of the contract and previous amendments remain in full effect except the additional scope of services in Amendment No. 1.

NOW THEREFORE, that in consideration of the covenants, agreements and representations hereinafter set forth, it is mutually agreed by the parties hereto that the Agreement entered into by the parties on February 14, 2023, is further amended as follows:

I. Additional Professional Services

The ENGINEER will provide continued project management services, in conformance with the attached Appendix A – Scope of Services (“Services”) by extending the services for a period of 2-year 4 month (28Months). The fee schedule for such Services is summarized below:

Project Management Services (Not to Exceed) in accordance with Appendix A	\$741,114
Total Services	\$741,114

The OWNER will compensate ENGINEER for engineering work associated with the Services outlined in Appendix A for a time and materials amount not to exceed seven hundred forty-one thousand, one hundred fourteen dollars (\$741,114.00). In the event OWNER requests extra work be performed that is not already identified in the tasks above or the amended Agreement, OWNER and ENGINEER will negotiate an additional fee for such work. Any additional fee negotiated must be agreed to in writing by the parties prior to any such extra work commencing. The OWNER represents that funding sources are in place with the available funds necessary to pay ENGINEER.

All other requirements of the Agreement remain in effect except those changed by contract amendments herein.

Project Management Services Amendment 1 Scope of Work and Fee Schedule

Exhibit B – SCOPE OF SERVICES

General

This scope of services supplements the Agreement dated February 14, 2023 for Project Management Services.

Project Description

Provide project management as described in the original contract scope of work. Attachment A (Schedule) of the original scope of work identified two one-year extensions. The purpose of this Amendment is to add those extensions plus four additional months. The four additional months are needed due to the use of funds for other staff supplements during the course of the first two years of the contract.

Schedule

The additional time shall begin in January 2025 and extend through April 2027 (28 months).

Compensation

The rate below reflects the hourly rate to provide Project Management Services.

Project Manager: \$171/hour

Total hours committed annually: 1860

Total time committed: 2 yrs, 4 months (2.33 years)

Total hours committed: 4334

Total labor compensation: \$741,114

No expenses are anticipated during this extended time period.
