# A RESOLUTION OF THE CITY OF LAWTON, OKLAHOMA (THE "CITY"), APPROVING AND AUTHORIZING THE MODIFICATION OF TERMS REGARDING A LETTER OF CREDIT NOTE, SERIES 2024C (THE "NOTE") TO BE ISSUED BY THE LAWTON WATER AUTHORITY (THE "AUTHORITY"); AND ALL MATTERS RELATED THERETO

WHEREAS, the Lawton Water Authority, a public trust (the "Authority"), has been created by a Trust Indenture for the use and benefit of the City of Lawton, Oklahoma (the "City"), under authority of and pursuant to the provisions of Title 60, Oklahoma Statutes 2021, Sections 176-180.4, inclusive, as amended and supplemented, the Oklahoma Trust Act and other applicable statutes of the State of Oklahoma; and

WHEREAS, the Trustees of the Authority have determined upon a financing plan consisting of providing funds for the purpose of securing funding for the closure and post-closure and/or corrective action cost estimates regarding the required financial assurance mechanism for the City's landfill facilities as required by the Oklahoma Department of Environmental Quality, said facilities being part of the "Utility Systems" of the Authority within the City; and pay costs of issuance related thereto (collectively, the "Project"); and

WHEREAS, in order to effect the said financing, the Trustees of the Authority approved on September 24, 2024, the incurring indebtedness in the aggregate principal par amount of not to exceed Ten Million Dollars (\$10,000,000), said indebtedness to be evidenced by the issuance of its Letter of Credit Note, Series 2024C or other evidences of indebtedness, in one or more series on a tax-exempt or taxable basis, at a premium or discount (the "Note"), of the Authority pursuant to the terms and conditions contained in a Letter of Credit Agreement (the "Letter of Credit Agreement") and related Note documents (together the "Note Documents") securing the Note;

WHEREAS, it is necessary and beneficial that the terms of the Note Documents and the Note be modified from a fixed interest rate set at time of issuance of the Note to a rate that will be determined at the time of draw upon the Letter of Credit to be fixed at the then 5 year Constant Maturity Treasury plus 2.50 percentage points, with the rate adjusting on each 5 year anniversary date of the first draw based on the then existing 5 year Constant Maturity Treasury plus 2.50 percentage points;

# BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAWTON, OKLAHOMA:

<u>SECTION 1.</u> The terms of the Note Documents and the Note shall be modified from the originally approved fixed interest rate set at time of issuance of the Note to a rate that will be determined at the time of draw upon the Letter of Credit to be fixed at the then 5 year Constant Maturity Treasury plus 2.50 percentage points, with the rate adjusting on each 5 year anniversary date of the first draw based on the then existing 5 year Constant Maturity Treasury plus 2.50 percentage points.

<u>SECTION 2.</u> By reason of the need for the benefit to the citizens of the City that can be realized with the Project and for the immediate preservation of the public peace, health and safety, this Resolution shall be effective immediately upon its adoption.

<u>SECTION 3.</u> In all other respects all the actions of the Authority and of the City taken on September 24, 2024, and taken on November 5, 2024, with respect to the issuance of the Note, modification of terms, and otherwise are hereby and by these presents expressly approved, confirmed, and ratified in all respects.

This resolution shall become effective immediately.
