A RESOLUTION AMENDING APPENDIX A, SCHEDULE OF FEES AND CHARGES, LAWTON CITY CODE, 2015, PERTAINING TO CHAPTER 7, BUSINESS, BY AMENDING ARTICLE A-7-12 TEMPORARY STRUCTURES AND USES, AND ESTABLISHING AN EFFECTIVE DATE.
