**A RESOLUTION AUTHORIZING AND DIRECTING THE ASSISTANT CITY ATTORNEY TO ASSIST MARCEL JORDAN IN FILING A FRIENDLY SUIT IN THE DISTRICT COURT OF COMANCHE COUNTY, OKLAHOMA, AGAINST THE CITY OF LAWTON; AND AUTHORIZING THE ASSISTANT CITY ATTORNEY TO CONFESS JUDGMENT THEREIN IN THE AMOUNT OF TWO THOUSAND TWO HUNDRED AND NO/100 DOLLARS (\$2,200.00).**

**WHEREAS**, on October 14, 2024, a City of Lawton water main broke, shooting water and debris on to Marcel Jordan's house, located at 1408 NW 33<sup>rd</sup> Street, Lawton, Oklahoma, causing damage in the alleged amount of \$42,657.86, as stated in his claim, which was filed with the City Clerk against the City of Lawton on October 18, 2024; and,

**WHEREAS**, it would be in the best interest of the City of Lawton to settle the claim by filing a friendly suit in the District Court of Comanche County and confess judgment therein.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Lawton, Oklahoma, that the Assistant City Attorney is hereby authorized and directed to assist Marcel Jordan in bringing suit in the District Court of Comanche County, Oklahoma, against the City of Lawton and to confess judgment therein in the amount of Two Thousand Two Hundred and No/100 Dollars (\$2,200.00).; and further, **BE IT RESOLVED** that the Mayor and City Clerk are hereby authorized to execute a written Warrant of Attorney directing the Assistant City Attorney to confess judgment against the City in said amount.


