

RESOLUTION NO. 21-_____

A RESOLUTION REPEALING RESOLUTION 82-73, RESOLUTION 94-98, RESOLUTION 97-90, RESOLUTION 98-206, RESOLUTION 99-75, RESOLUTION 06-34, RESOLUTION 07-44, RESOLUTION 08-160 AND RESOLUTION 11-111, AND AUTHORIZING THE TRANSFER OF THE EXISTING FUND BALANCES.

WHEREAS, Resolution 82-73 created the Insurance Proceeds Fund, a/k/a City of Lawton Fund 20, which is no longer necessary due to many of the repairs being made using General Fund money prior to the receipt of insurance proceeds; and

WHEREAS, Resolution 94-98 created the Application Fee Fund, a/k/a City of Lawton Fund 68, which is no longer necessary with the implementation of Tyler; and

WHEREAS, Resolution 97-90 created the Municipal Court Credit Card Maintenance Fund, a/k/a City of Lawton Fund 29, which is no longer necessary with the implementation of Tyler; and

WHEREAS, Resolution 98-206 created the Animal Welfare Donation Fund, a/k/a City of Lawton Fund 23, which is no longer necessary with the implementation of Tyler; and

WHEREAS, Resolution 99-75 created the Real Property Proceeds Fund, a/k/a City of Lawton Fund 78, which is no longer necessary due to the low cost of selling surplus property in recent years; and

WHEREAS, Resolution 06-34 created the Jail Fee Fund, a/k/a City of Lawton Fund 76, which is no longer necessary with the implementation of Tyler; and

WHEREAS, Resolution 07-44 created the Lease and Rentals Fund, a/k/a City of Lawton Fund 43, which is no longer necessary with the implementation of Tyler; and

WHEREAS, Resolution 08-160 created the Recycling Fund, a/k/a City of Lawton Fund 80, which is no longer necessary with the implementation of Tyler; and

WHEREAS, Resolution 11-111 created the Rental Revenue Fund, a/k/a City of Lawton Fund 81, which is no longer necessary with the implementation of Tyler.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of Lawton, Oklahoma that:

Section 1. Resolution 82-73 is hereby repealed and the Insurance Proceeds Fund a/k/a City of Lawton Fund 20, is hereby closed and any remaining fund balance shall be transferred to General Fund, a/k/a City of Lawton Fund 01.

Section 2. Resolution 94-98 is hereby repealed and the Application Fee Fund, a/k/a City of Lawton Fund 68, is hereby closed and any remaining fund balance shall be transferred to the City of Lawton General Fund.

Section 3. Resolution 97-90 is hereby repealed and the Municipal Court Credit Card Maintenance Fund, a/k/a City of Lawton Fund 29, is hereby closed and any remaining fund balance shall be transferred to the City of Lawton General Fund.

Section 4. Resolution 98-206 is hereby repealed and the Animal Welfare Donation Fund, a/k/a City of Lawton Fund 23, is hereby closed and any remaining fund balance shall be transferred to the City of Lawton General Fund.

Section 5. Resolution 99-75 is hereby repealed and the Real Property Proceeds Fund, a/k/a City of Lawton Fund 78, is hereby closed and any remaining fund balance shall be transferred to the City of Lawton General Fund.

Section 6. Resolution 06-34 is hereby repealed and the Jail Fee Fund, a/k/a City of Lawton Fund 76, is hereby closed and any remaining fund balance shall be transferred to the City of Lawton General Fund.

Section 7. Resolution 07-44 is hereby repealed and the Lease and Rentals Fund, a/k/a City of Lawton Fund 43, is hereby closed and any remaining fund balance shall be transferred to the City of Lawton General Fund.

Section 8. Resolution 08-160 is hereby repealed and the Recycling Fund, a/k/a City of Lawton Fund 80, is hereby closed and any remaining fund balance shall be transferred to the City of Lawton General Fund.

Section 9. Resolution 11-111 is hereby repealed and the Rental Revenue Fund, a/k/a City of Lawton Fund 81, is hereby closed and any remaining fund balance shall be transferred to the City of Lawton General Fund.

Section 10. This resolution shall be effective on July 1, 2021.
