RESOLUTION NO. 21-____

A RESOLUTION ESTABLISHING THE CITY OF LAWTON SPECIAL REVENUE FUND, REPEALING RESOLUTION 74-112, RESOLUTION 78-146, RESOLUTION 97-140, AND RESOLUTION 03-174, AND AUTHORIZING THE TRANSFER OF THE EXISTING FUND BALANCES.

- **WHEREAS,** the City wishes to combine all current grant funds into one master Grant Fund for the Tyler implementation; and
- **WHEREAS,** Resolution 74-112 created the Retired Senior Volunteer Program Fund, a/k/a City of Lawton Fund 57, which is no longer necessary with the implementation of Tyler; and
- **WHEREAS,** Resolution 78-146 created the Police Grant Fund, a/k/a City of Lawton Fund 63, which is no longer necessary with the implementation of Tyler; and
- **WHEREAS,** Resolution 97-140 created the Park Fund, a/k/a City of Lawton Fund 72, which is no longer necessary with the implementation of Tyler; and
- **WHEREAS,** Resolution 03-174 created the Federal Grant Fund, a/k/a City of Lawton Fund 40, which is no longer necessary with the implementation of Tyler.
- **NOW, THEREFORE, BE IT RESOLVED,** by the Council of the City of Lawton, Oklahoma that:
- <u>Section 1.</u> There is hereby established a Grant Fund for the purposes of receiving and disbursing all grant funds.
- Section 2. Resolution 74-112 is hereby repealed and the Retired Senior Volunteer Program Fund, a/k/a City of Lawton Fund 57, is hereby closed and any remaining fund balance shall be transferred to the City of Lawton Grant Fund.
- Section 3. Resolution 78-146 is hereby repealed and the Police Grant Fund, a/k/a City of Lawton Fund 63, is hereby closed and any remaining fund balance shall be transferred to the City of Lawton Grant Fund.
- Section 4. Resolution 97-140 is hereby repealed and the Park Fund, a/k/a City of Lawton Fund 72, is hereby closed and any remaining fund balance shall be transferred to the City of Lawton Grant Fund.
- Section 5. Resolution 03-174 is hereby repealed and the Federal Grant Fund, a/k/a City of Lawton Fund 40, is hereby closed and any remaining fund balance shall be transferred to the City of Lawton Grant Fund.
 - Section 6. This resolution shall be effective on July 1, 2021.
