**A RESOLUTION AMENDING RESOLUTION 99-62, WHICH CREATED CERTAIN CITY OF LAWTON FUNDS THAT ARE NO LONGER NEEDED OR CAN BE COMBINED WITH OTHER FUNDS, AND AUTHORIZING THE TRANSFER OF THE EXISTING FUND BALANCES.**

**WHEREAS,** Resolution 99-62 created the State Landfill Fee Fund, a/k/a City of Lawton Fund 02, which is no longer necessary with the implementation of Tyler; and

**WHEREAS,** Resolution 99-62 created the Hunt and Fish Cash Fund, a/k/a City of Lawton Fund 03, which is no longer necessary with the implementation of Tyler; and

**WHEREAS,** Resolution 99-62 created the General Investment Fund, a/k/a City of Lawton Fund 08, which is no longer necessary with the implementation of Tyler; and

**WHEREAS,** Resolution 99-62 created the Animal Welfare Neuter Fund, a/k/a City of Lawton Fund 18, which is no longer necessary with the implementation of Tyler; and

**WHEREAS,** Resolution 99-62 created the Payroll Claims Fund, a/k/a City of Lawton Fund 24, which is no longer necessary with the implementation of Tyler; and

**WHEREAS,** Resolution 99-62 created the Adult Softball Fund, a/k/a City of Lawton Fund 25, which is no longer necessary with the implementation of Tyler; and

**WHEREAS,** Resolution 99-62 created the Animal License Fund, a/k/a City of Lawton Fund 42, which is no longer necessary with the implementation of Tyler; and

**WHEREAS,** Resolution 99-62 created the Park Fee Fund, a/k/a City of Lawton Fund 43, which is no longer necessary due to prolonged inactivity; and

**WHEREAS,** Resolution 99-62 created the Library Grants Fund, a/k/a City of Lawton Fund 59, which is no longer necessary with the implementation of Tyler; and

**WHEREAS,** Resolution 99-62 created the Cemetery Reward Fund, a/k/a City of Lawton Fund 74, which is no longer necessary due to prolonged inactivity; and

**WHEREAS,** Resolution 99-62 created the Wastewater Maintenance Fund, a/k/a City of Lawton Fund 96, which is no longer necessary with the implementation of Tyler.

**NOW, THEREFORE, BE IT RESOLVED,** by the Council of the City of Lawton, Oklahoma that:

Section 1. Resolution 99-62 is hereby repealed.

Section 2. The State Landfill Fee Fund, a/k/a City of Lawton Fund 02, is hereby closed and any remaining fund balance shall be transferred to the City of Lawton Enterprise Fund.

Section 3. The Hunt and Fish Cash Fund, a/k/a City of Lawton Fund 03, is hereby closed and any remaining fund balance shall be transferred to the City of Lawton General Fund.

Section 4. The General Investment Fund, a/k/a City of Lawton Fund 08, is hereby closed and any remaining fund balance shall be transferred to the City of Lawton General Fund.

Section 5. The Animal Welfare Neuter Fund, a/k/a City of Lawton Fund 18, is hereby closed and any remaining fund balance shall be transferred to the City of Lawton General Fund.

Section 6. The Payroll Claims Fund, a/k/a City of Lawton Fund 24, is hereby closed.

Section 7. The Adult Softball Fund, a/k/a City of Lawton Fund 25, is hereby closed and any remaining fund balance shall be transferred to the City of Lawton General Fund.

Section 8. The Animal License Fund, a/k/a City of Lawton Fund 42, is hereby closed and any remaining fund balance shall be transferred to the City of Lawton General Fund.

Section 9. The Park Fee Fund, a/k/a City of Lawton Fund 43, is hereby closed and any remaining fund balance shall be transferred to the City of Lawton Special Revenue Fund.

Section 10. The Library Grants Fund, a/k/a City of Lawton Fund 59, is hereby closed and any remaining fund balance shall be transferred to the City of Lawton Grant Fund.

Section 11. The Cemetery Reward Fund, a/k/a City of Lawton Fund 74, is hereby closed and any remaining fund balance shall be transferred to the City of Lawton Special Revenue Fund.

Section 12. The Wastewater Maintenance Fund, a/k/a City of Lawton Fund 96, is hereby closed and any remaining fund balance shall be transferred to the City of Lawton Enterprise Fund.

Section 13. This resolution shall be effective on July 1, 2021.
