

**RESOLUTION NO. 21-\_\_**

A RESOLUTION AUTHORIZING AN INCREASE IN CAMPGROUND RELATED RATES AT LAKES ELLSWORTH AND LAWTONKA AS SET FORTH IN EXHIBIT "A" OF THIS RESOLUTION, PROPOSED FOR IMPLEMENTATION BY THE CITY OF LAWTON IN APPENDIX A, SCHEDULE OF FEES AND CHARGES, LAWTON CITY CODE, 2015, AND ESTABLISHING AN EFFECTIVE DATE.

**WHEREAS**, the City of Lawton Parks and Recreation Department and the Lakes and Land Commission has determined that there has been a continuous increase in lake activity and use of lake facilities that has resulted in increased operational costs and, despite such increases, there has been no corresponding increase in fees charged for campground usage since 2015; and

**WHEREAS**, the City of Lawton Parks and Recreation Department and the Lakes and Land Commission has determined that an increase in campground related fees at Lakes Ellsworth and Lawtonka is necessary to help offset said increased operational costs; and

**WHEREAS**, Section 1-2-205(A), Lawton City Code, 2015, provides that fees and charges be set by resolution.

**NOW, THEREFORE BE IT RESOLVED** by the Mayor and Council of the City of Lawton, Oklahoma that:

Section 1. APPENDIX A, Schedule of Fees and Charges, Lawton City Code, 2015, be amended as set out in the attached Exhibit "A".

Section 2. EFFECTIVE DATE. The provisions of this resolution shall be in full force and effective on the 8th day of July 2021.
