Wilson stated LIDA convened earlier today at 1:00 PM and voted to approve the note. The Council's subsequent resolution would serve to affirm this decision. The resolution specifically authorizes the incurred indebtedness, and due to the waiver of competitive bidding, it necessitates a 3/4 majority vote.

Kameron Good from the Planning Division presented details concerning a rezoning request for the property located at 1201 SW C Avenue. Situated at the Northwest corner of C Avenue and 12th Street, the property comprises lots 20 through 24 and is currently vacant. The proposed use for the property is a daycare facility, with plans for two curb cuts onto 12th Street. Presently, the land is designated as Residential High Density, surrounded by similar zoning to the North, South, and West, while Commercial zoning lies to the East. The proposal aims to rezone the property for commercial purposes.

Good further stated that notices were sent to 24 property owners within 300 feet of the location on February 7th and published in the Lawton Constitution on February 9th. There were no received phone calls either in favor or against the proposal.

Additionally, Good explained that the matter was presented to the City Planning Commission on January 11th, but due to an error in the initial newspaper notice referencing the wrong section of the City Code, the proposal was re-noticed and brought back to the Commission. Subsequently, on February 29th, the City Planning Commission recommended approval of the rezoning request.

The public hearing was opened and closed with no comments.

Kameron Good, Planning Division, presented an ordinance pertaining to zoning changes following the previous alterations in the Land Use Plan. Currently, the zoning designation for the area is R-4, with R-4 zoning to the North, West, and South, and C-5 zoning to the East. The proposed zoning change is to C-1, which permits the operation of a daycare facility as a permitted use.

Good further stated that notices were sent to 24 property owners within 300 feet of the area on February 7th and published in the Lawton Constitution on February 9th. The matter was brought before the City Planning Commission (CPC) on February 11th, although a notice issue prompted it to be revisited on February 29th. Subsequently, the CPC made a recommendation to approve the zoning request.

To fulfill these obligations, SCS is the chosen company to assist with the design of the landfills, as well as to provide specialized inspectors who meet ODEQ standards.

Charlotte Brown, Community Services, clarified that the ordinance in question had been approved in June with some floor amendments. However, due to missing the publication deadline, it is being revisited. The current version of the ordinance being presented today includes the previously approved floor amendments.

During the discussion, Harris noted the removal of "religious" from the descriptions in the ordinance and inquired about the rationale behind this change.

Brown explained that the removal of "religious" was a floor amendment proposed by Councilman Weger and subsequently approved by the Council in June.

Harris then raised concerns about the abundance of signs related to construction and roofing businesses and questioned whether such businesses require a door-to-door license.

Brown clarified that businesses only require a license if they are engaged in door-to-door activities.

Harris further inquired about regulations concerning advertising businesses on City right-of-ways.

Brown confirmed that the current code prohibits advertising on right-of-ways. She pledged to instruct Neighborhood Services to remove such signs, noting instances she had observed herself, particularly on Rogers Lane.

Hankins added that it is her understanding that some roofing companies offer benefits to homeowners for displaying their signs, which could contribute to the issue. She suggested that while it's reasonable to have signs up during ongoing work, they should be taken down once the work is completed.

Craig Akard, Human Resources, explained that in August 2021, the Council passed an ordinance allowing employees with over 10 years of service and more than 280 hours of vacation time to cash out the excess hours, up to 100 hours, at 75% of their hourly pay rate. However, many employees with 5 to 10 years of service were losing accrued vacation time exceeding 280 hours if not used by the first pay period in January. The proposed amendment aims to address this issue by lowering the eligibility requirement to 5 years of service and making the cash-out process automatic, eliminating the need for employees to notify HR and sign up.

Akard further noted that in January of the current year, employees across the City lost a total of 706 hours of vacation time because they didn't meet the 10-year service requirement or failed to sign up for cash-out.

Gill sought clarification on whether this applied to accrued, paid vacation leave, to which Akard confirmed.

Wilson mentioned that as this amendment falls under Chapter 17, it must be reviewed by the Employee Advisory Committee, but Akard had not provided their position.

Akard clarified that the amendment had been presented to the Employee Advisory Committee on March 7th, and they had approved it.

Weger inquired about the limit on cash-out hours, to which Akard explained that the previous limit of 100 hours had been removed in this version, and now employees would automatically receive payment for any accrued hours over 280.

Craig Akard, Human Resources, explained the current provision in the City Code requiring employees to give 30 days notice to their director or the City Manager if they intend to take terminal leave before retiring. He highlighted the challenge arising from the short notice period, particularly concerning hiring and training, especially for supervisory roles. The proposed amendment seeks to extend the notice period to 90 days for general employees and 120 days for executive-level positions.

Akard further mentioned that the proposed amendment was reviewed by the Employee Advisory Committee (EAC) on March 7th. The EAC recommended adding an amendment to Section 167.a, granting the City Manager the authority to make exceptions for good cause on a case-by-case basis. This provision would accommodate unforeseen circumstances, such as medical issues preventing an employee from returning to work, where a shorter notice period may be necessary.

Ratliff expressed agreement with Akard's proposal, particularly emphasizing the inadequacy of a 30-day notice period, especially for executive positions. He supported the initiative, noting that extending the notice period to 120 days would facilitate better vacancy advertisement and filling procedures.

Joe Painter, Engineering Department, provided an update on the Gore Blvd project spanning from 67th to 82nd Street. He explained that the Oklahoma Department of Transportation (ODOT) is overseeing the project as they have contributed to its funding and are leading its execution. However, there has been a budget overrun of approximately \$2.2 million. Painter disclosed that he had advocated for the city with ODOT, resulting in an agreement for an 80/20 split on the excess costs.
